without charges having been filed, or verification of the truthfulness of the information; highlights the Genevan Commons Screenshots website, which contains disparaging comments, private communication, allegations of wrongdoing, and information presented in misleading and false ways; and was done without the knowledge or permission of those accused, or without any way for those to restore their good name.

This was done despite no charges having been filed against Mr. Jason R and many of the instances describe had not been verified with the witnesses, or had been brought to Mr. Jason R's attention, and were personal grievances. This action made concerns that were unverified and had not been charged, public, creating unnecessary tension between New Hope Members and the Elders of New hope, and disturbing the peace, purity and unity of the church.

This document included personal communications of Mr. Jason R. without his knowledge or permission. This document and the information contained in it had been discussed by session in meetings with Mrs. Aimee B., and was read and edited by Mrs. Aimee B., yet session had not met with Mr. Jason R. on this, and had not shared this document with him, leading to a one-sided presentation of the information. In addition, the document explained concerns session had with Mr. Jason R's complaint prior to Presbytery even processing his appeal. Making this information public, and presenting only one side of it disturbed the peace, purity and unity of the church.

The letter disparages the name of members of the group regardless of their level of involvement or knowledge of any alleged offenses; makes allegations of wrongdoing without charges having been filed, or verification of the truthfulness of the information; highlights the Genevan Commons Screenshots website, which contains disparaging comments, private communication, allegations of wrongdoing, and information presented in misleading and false ways; and was done without the knowledge or permission of those accused, or without anyway for those to restore their good name. This action greatly disturbed the peace, purity and unity of the OPC.

Specification 1: On April 21, 2020 session of New Hope, including Mr. Francis VanD. sent out an email responding to the complaint filed against them that stated while there were some areas they did not do as they should have, "we do not believe we sinned or erred".

Specification 2: On September 19, 2020 Session of New Hope, including Mr. Francis VanD., during a meeting of the Presbytery of the Mid-Atlantic stated, in response to discussion related to a complaint filed against the Session of New Hope, "we messed up, we see that," and went on to say, we got it, we understand what Presbytery is telling us, we messed up. However, after the Presbytery meeting session approved a motion at their next meeting to appeal the decision of Presbytery and made an announcement to the church stating that they would appeal the Presbytery decision. Also, session sought to again censure Mr. Jason R. without trial by telling him he should not take communion on October 4th, 2020, and giving the fact that he took communion as one of the reasons for suspending him from the duties of office on October 10, 2020. In addition, Session did the same action that the complaint was about, by telling congregants to come to the trial against Mr. Jason R. to hear session's concerns and then making the same accusations against Mr. Jason R. (accusations that were not part of the charges) both during session's opening statement and their closing statements. Further, session members, both in private

and at the trial, would not say that what they did was censure, instead stating that the actions being wrong are "what Presbytery ruled". Additionally, they did no work to restore or repair the situation after the complaint was sustained, still placing the blame on Mr. Jason R. despite what Presbytery had ruled and their comments at the Presbytery meeting.

Mr. Francis VanD. failed to give an answer as to whether he believed it was wrong, stating, "Yes, Presbytery ruled on that." When asked was the backstory an error in policy or procedures, Mr. Francis VanD. failed to give an answer as to what he believed and said, "Presbytery ruled on that in the affirmative."
